# PHISHING SCAMS & NHA WHAT YOU NEED TO KNOW TO PROTECT YOURSELF!

Phishing is a type of online scam that targets consumers by sending them an e-mail that appears to be from a well-known source – such as an internet service provider, a bank, or could pretend to be from Norfolk Housing.

It asks the consumer (YOU) to provide personal identifying information. Then a scammer uses the information to open new accounts, or invade the consumer's existing accounts.

There ARE instances when Norfolk Housing will request personal information. So here we will explain exactly how Norfolk would request that personal information to avoid these phishing scams.

First if there are every any concerns with an email or letter that you have received from Norfolk Housing Staff, do not hesitate to verify it by contacting the Norfolk Office at 403-270-3062 or by visiting us during business hours Monday – Friday from 9:30 am – 4:00 pm. The office is located at 1118 Kensington Road N.W.

Emails from Norfolk Housing Staff will always have **@norfolkhousing.ca** at the end of it (example: jon.h@norfolkhousing.ca).

### **RENT**

All requests concerning rent, whether it is a missed payment or changes to rental amount, will always first be presented to a resident in the form of a letter. If it requires more attention, further inquiries may be done by phone or email.

#### **INSURANCE**

Having up-to-date tenant insurance is a requirement of residency at Norfolk Housing. If Norfolk staff notice that insurance policies have expired on our records, they will contact the residents. These requests will typically come in the form of an email or phone call.

#### **PROOF OF INCOME**

For those of our residents that are a part of the NHA Subsidy program, there is a requirement at least once a year to provide proof of income to maintain the subsidy. This request will always come in the form of a letter first. If it requires more attention, further inquiries may be done by phone or email.

#### **LEASES**

Leases are either dropped off at your door, or will be sent to the email that you have supplied to us using Docusign. Docusign allows for our leases to be signed safely, electronically. This will be the default way to receive leases unless you have asked for us to physically deliver them.

### **UPDATED RESIDENT INFORMATION**

This typically will accompany a lease. This is to ensure that the information that we have on file is complete and correct.

There are so many variation of scams out there we ask that if you are ever unsure to contact the Norfolk Housing Office before supplying sensitive and personal information.



# **SUBMIT A MAINTENANCE REQUEST!**

We LOVE to hear from you and promise, it's never a bother to know what's going on (or going wrong) in your unit.

Please be diligent and let us know as soon as something happens that may be an indication of a problem in your unit - like the heat suddenly doesn't seem to work, the sink isn't draining, or there's a drip or leak somewhere.


